3. Rink planning (1 hour)

Today we are joined by some of the rink volunteers who wish to discuss the rink maintenance budget and their vision for the rink in the coming years.

Where is the city on proposed budgets this year?

As far as we know the city is still planning for a regular rink season. As an outdoor venue, it can easily be adapted for covid 19 restrictions. We don't have any staff either so it means fewer complications. However, the city may change things before the season begins.

Discussion of rink budget with the volunteers

The board and the rink volunteers discuss the draft budget for the rink. The budget was amended with the rink volunteer's input.

The rink volunteers raised a question about the city removing snow from the rink for free after a significant snowfall. They mentioned that the city has done this for the Queenswood Heights rink operator in the past.

Gary will inquire with Emma our contact with the city.

Miranda and Mireille caution that the other rink is on city property adjacent to a Community center. Sidewalk plows would already be on site at that location serving the community center. In our case, the city would have to bring one in just for our rink.

Five-year vision for the rink

- Capital improvements things we need to build with the city or possibly with the help of private business partners.
- We want to talk about having a caban
- We would like to have the cement pad replaced
- We would like to see a cement pad for the puddle rink
- We would like to see a barrier to protect the water spot.
- Long term we would like some sort of roof over the rink.
- Miranda suggested a walkability safety audit for some of those simpler issues.
- Such as a barrier around the water source and some barriers to cars for the rink area.
- If possible, have some sort of hinges so that we can open up the chainlink to toss snow out of the rink.
- If we have one section open it would make it easier for snow removal.
