    - i. The puddle rink never materialized.

- 6. Traffic calming: proposal for a working group Natalie
  - Natalie previously proposed a sub-community for our community association to look at this issue.
  - A subcommittee would be good however it wouldn't meet at the same time as the board.
    - i. However, the chair of the traffic calming subcommittee would have to attend meetings to report to the board.
  - Miranda suggests that we have one traffic calming working group and another working group focused on the interprovincial bridge. Mireille suggested to keep them in the same group at the beginning. Then form a second group later when it gets bigger.
  - Shen's Update on traffic calming:
    - i. She has sent a letter to Bryere and had a meeting and had a meeting with Councillor Matt Luloff and Mireille.
    - ii. The meeting went well, the Matt listened wanted to be part of the solution
    - iii. Action items for this issue: they want to get the speed data. Rylie Carter will get a new speed study done in the spring.
    - iv. Petition the homes around the area to put up no right-hand turn signs at certain times of the day.
    - v. Matt was confident that if he would need the council's approval he was confident he could get it.

#### 7. NCC – new interprovincial bridge

- CGOWCA's position
  - i. The Board is unable to take a position at this time on such a contentious issue without consulting the residents of our area.
- Resident engagement
  - i. Mike's concerns: He does not want a bridge going through the greens creek area where many residence bikes walk and ski to the Ottawa river lookout. There was some confusion, to be clear he was not concerned about Residence losing their homes, the proposed bridge will go through the green belt. However, he is concerned the bridge may impact the McLaren Bay conservation area on the Quebec side and the lookout on the Ontario side.
  - ii. The kettle Island bridge would be preferable, however many residences simply don't want it on this end of town.
